## Presentation

---

If the issue of religion at work is not a new one, it is becoming a growing concern in the world of work where the employers have to cope with various demands of their employees and where the employees wish to reconcile religious and professional practices. In France, for more than 6 years, the judicial debates focused on the Baby Loup case. These disputes have gone beyond the classic purpose of interpreting labor law rules by specialized lawyers to become a central societal issue. These debates reveal a reconfiguration of relations between the State, citizens and religion. This reconfiguration is neither completed nor stabilized, it is underway in France as elsewhere. The answer given by the Plenary Assembly of the Court of Cassation on June 25, 2014 in the Baby Loup case has not dried up the litigation which has been brought before the European jurisdictions. The judgments of the Court of Justice of the European Union, on 17 March 2017, redefine the legal approach of the issue.

This reconfiguration in France can not be isolated from the changes that are underway in other countries, particularly in Europe. The conference will bring together different national experiences. In addition to the French case, German, American, Belgian, Canadian, Spanish, Italian, Dutch, Hungarian, Portuguese, Romanian, Swedish and Turkish experiences will be presented, compared and discussed. The conference will also be an opportunity to question the reconciliation of the different European approaches to the issue of religion at work (of the European Court of Human Rights and the Court of Justice of the European Union) and the practices of companies.
